

# **Privacy Policy**

#### 1. Your Privacy is Important

At Bilston Group your right to privacy is important. Bilston Group is subject to the National Privacy Principals ("NPPs") under the Privacy Act 1988 (C'th). The following statement outlines how Bilston Group manages personal information that it holds about individuals in accordance with the NPPs.

This Policy also includes our credit reporting policy, that is, it covers additional information on how we manage your personal information collected in connection with a credit application, or a credit facility. We refer to this credit-related information below as "credit information".

### 2. Personal Information – what is it?

Personal information is any information or an opinion about you (whether true or not) from which Bilston Group can determine your identity. The types of information that we collect and hold about you could include:

- ID information such as your name, postal or email address, telephone numbers, and date of birth;
- financial details such as your tax file number; and
- other information which we think is necessary.

### 3. Sensitive Information – what is it?

When personal information concerns certain matters it is considered sensitive information. It is information or opinion about your:

- racial or ethnic origin;
- political opinion;
- membership of a political association;
- religious beliefs, affiliations or philosophical beliefs;
- membership of a professional or trade association or membership of a trade union;
- criminal record;
- financial records.

Bilston Group will only collect, use or disclose sensitive information about you in accordance with the law. In most cases, Bilston Group will only collect, use or disclose sensitive information where it has received your consent.

#### 4. How your information will be collected

Generally, Bilston Group collects personal information directly from you. For example, it collects personal information when you:

- deal with Bilston Group in person, by telephone, letter, fax or email;
- supply a resume;
- submit any other information in connection with your application for registration.

Personal information about you may also be collected from a third party. For example, when Bilston Group receives:

- your employer, accountant, real estate agent or other referees;
- your agents and other representatives like the person who referred your business to us, your solicitors, conveyancers and settlement agents;
- organisations that check the security you are offering such as valuers;
- bodies that issue identification documents to help us check your identity; and
- any reference about you;
- results of inquiries of former employers, work colleagues, professional associations or registration body;
- the results of any competency or medical test;
- performance feedback (whether positive or negative);
- any complaint from or about you in the workplace;
- any information about any insurance investigation, litigation, registration or professional disciplinary matter, criminal matter, inquest or inquiry in which you are involved.

If Bilston Group does not have your prior consent, it will take reasonable steps to inform you that it has collected personal information from a third party and ensure you are aware of the purposes for which Bilston Group has collected your personal information.

If you don't provide your information to us, it may not be possible for us to give you the assistance you seek, to verify your identity or protect against fraud or to let you know about other products or services that might be suitable for your financial needs.

# 5. How Bilston Group may use and disclose your personal information

Bilston Group may use and disclose the personal information it collects about you for the following purposes:

• for purposes for which you have engaged Bilston Group.

Bilston Group may disclose some of your personal information to:

- Regulatory bodies and/or clients of Bilston Group;
- referees;

Bilston Group may also disclose your personal information to a third party if they have a proper interest in the disclosure, such as:

- other members of the Bilston Group;
- Bilston Group' insurers;
- a professional association or registration body;
- referrers that referred your business to us;
- valuers;

- organisations, like fraud reporting agencies, that may identify, investigate and/or prevent fraud, suspected fraud, crimes, suspected crimes, or other misconduct;
- government or regulatory bodies (including ASIC and the Australian Tax Office) as required or authorised by law. In some instances, these bodies may share the information with relevant foreign authorities;
- service providers, agents, contractors and advisers that assist us to conduct our business;
- any organisation that wishes to take an interest in our business or assets; and
- any third party to which you consent to us sharing your information.

If Bilston Group engages a third-party contractor to perform services which involves handling personal information, it takes reasonable steps to prohibit the contractor from using personal information except for the purposes for which it was supplied.

If you do not give Bilston Group the information it seeks, it is unable to provide you with services.

# 6. Security of your personal information

Bilston Group holds personal information in a secure computer storage facility. Bilston Group has security procedures in place to protect the personal information it holds from misuse, loss, unauthorised access, modification or disclosure. Bilston Group uses a number of processes to protect your personal information including:

- locks and security systems;
- computer pass words and limited access to shared network drives to authorised staff;
- virus checking;
- auditing procedures and data integrity checks;
- recording of file movements;
- security classification to identify information needing special protection.

Bilston Group will keep your personal information no longer than necessary. Bilston Group will appropriately dispose of your personal information so that it is protected from unauthorised use or disclosure.

# 7. You can request access to your information

You may request access to any personal information Bilston Group holds about you, subject to the Privacy Act. Your request to obtain access will be dealt with in a reasonable time. Bilston Group may charge a fee to cover the reasonable costs of retrieval and supply of the information to you.

Bilston Group is not always required to provide you with access to your personal information on request. Bilston Group may refuse your access to personal information in a number of circumstances, such as where denying access is required or authorised by law or where the request is vexatious or frivolous.

If Bilston Group denies your request for access it will provide you with reasons for the refusal.

# 8. Keeping your personal information up to date

Bilston Group takes reasonable steps to ensure that your personal information is accurate, complete and up to date. Bilston Group may also contact you from time to time to check that the information is still correct.

If you are able to establish that personal or sensitive information Bilston Group holds about you is not accurate, complete and up to date, Bilston Group will take reasonable steps to correct it.

If Bilston Group is unable to agree that the personal information it holds about you is accurate, complete and up to date, you may ask Bilston Group to place with the information, a statement by you claiming that the information is not accurate, complete and up to date.

# 9. Transfer of your personal information outside Australia

Bilston Group does not transfer your personal information outside Australia unless it is authorised to do so by law or you have consented to it as part of the recruitment services it provides to you.

Bilston Group may store your personal information on a server overseas. By providing personal information via Bilston Group' website you agree your information may be transferred to servers located overseas.

#### 10. How do you make a complaint?
